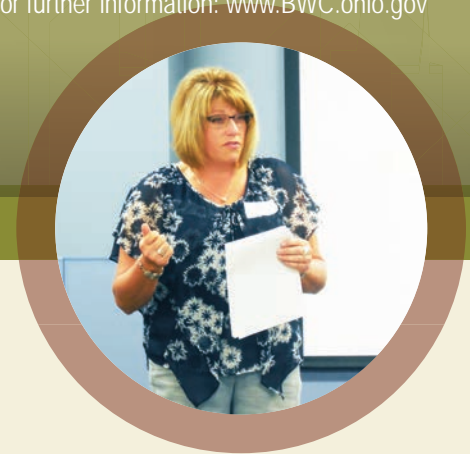

Eligibility Requirements

Thousands of Ohio employers find value and workers' compensation premium savings by actively participating in their local safety councils...you can join them!

To **qualify** for the BWC Safety Council rebate, you must meet the following eligibility requirements:

- Join your local safety council by July 31 of the current program year.
- Attend 10 meetings or events, at least 8 through the local safety council. Employers can earn a maximum of two external training credits.
- CEO (highest ranking authority) has to attend at least one safety council hosted meeting or special event.

Safety Council Rebate

Eligible employers actively participating in the local safety council program July 1, 2015 to June 30, 2016 will receive a rebate of 2% on their annual premium.

Eligible employers who reduce their frequency rate and severity rate by at least 10% or maintain their rate may receive an additional 2% rebate on their annual premium.
